Released, waive, discharge and covenant not to sue the, ALBORNOZ KARATE SCHOOL LLC. its officers, its affiliated clubs, regional sports organizations, their respective administrators, directors, agents, coaches and other employees, staff, official and volunteers of each of the undersigned, his or her heirs and next of kin of any and all claims, demands, losses or damages on account of injury including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the release or otherwise. The undersigned shall indemnify he releases and hold them harmless for any losses, liabilities or damages which may result from any failure or defect of such release.
